# What is CASA?

CASA, <u>Court Appointed Special A</u>dvocates, is a non-profit organization dedicated to providing quality intervention and advocacy services to abused and neglected children in Merced County. CASA provides training, supervision and ongoing support to Advocates who work with children in the foster care system. Each Advocate is matched one-on-one with a child and acts as his or her champion.

#### **CASA Advocates**

CASA Advocates are ordinary people with extraordinary hearts and the desire to make a difference. Advocates must be at least 21 years old and are asked to make an 18 month commitment in order to ensure stability and consistency for the children they serve.

#### What Do Advocates Do?

A CASA Advocate visits with a child on a regular basis, interacts with professionals involved in the case and makes recommendations directly to the court, ensuring the child's best interests are not overlooked. Advocates make a commitment of 10-15 hours per month.

## How Do I Become An Advocate?

The first step in becoming a CASA Advocate is to attend an information session to learn what an Advocate's responsibilities are and how the CASA organization will support you. A current Advocate will share experiences and answer all of your questions. Next, an interview and a 30 hour training series is required. After successfully completing all requirements, Advocates are sworn in as an officer of the court. For more information, call (209) 722-2272.
