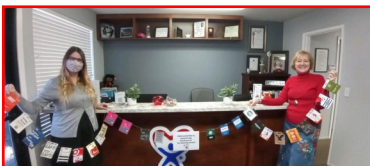
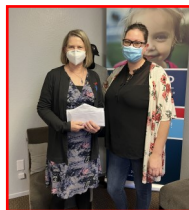


Mansion House Fundraiser
